3 Phases

The Dyslexia & Processing Evaluation takes place in three phases:

- 1. A 90-minute Evaluation. This evaluation reviews several areas of your child's sensory processing systems. This battery of evaluations is administered by an ACHIEVE evaluation aide. Additionally, there are a number of parent-response surveys/questionnaires that may be completed during or prior to the evaluation appointment. The areas evaluated include:
 - Phonological Processing (Decoding, Encoding, Phonemic Awareness),
 - Speech/Language Development,
 - Auditory Processing,
 - Eye Tracking and Eye Teaming,
 - Visual Information Processing, and
 - Mental Health, Emotional, and Social Factors.

- 2. **Individualized Report and Plan.** Following the evaluation, our team aggregates and assesses the results, then collaborates with an ACHIEVE doctor who formulates an individualized report and plan for your child. This informative synopsis includes:
 - Details of each evaluation area,
 - Evaluation results with your child's scores and their meanings, and
 - Doctor's direction, including:
 - Recommendations of interventions that relate to areas of deficit,
 - Referral information of vetted professionals who specialize in these interventions, and
 - A treatment plan that outlines overall solutions and specific next steps in helping your child overcome their learning challenge and achieve their potential.
- 3. **Doctor Report and Review Meeting**. During this meeting, the child's parent(s)/guardian(s) (without the child present) and an ACHIEVE doctor will review and discuss the findings and recommended next steps. At the end of the meeting, you will:
 - Have new insights and a fresh level of understanding of your child's reality and needs,
 - Understand why previous efforts to address your child's challenges have fallen short,
 - See the connections between your child's sensory processing systems in a comprehensive way—a first-of-its-kind benefit pioneered by ACHIEVE Learning Sciences,
 - Know the recommended next steps, in order of integrated priority, in your child's journey to overcome his/her challenges,
 - Have all the information you need to make informed decisions regarding your child's needs.
